

Privacy Statement: PTS Logistic Solution

Privacy protection is carried out in accordance with the Privacy Statement published on this website (hereinafter: Website).

For the purpose of this Privacy Statement, personal data and electronic records that belong to the sphere of personality are as listed:

- name and surname,
- address,
- telephone number,
- e-mail address,
- website,
- information about workplace and other engagement,
- any other data, serving for the identification of natural persons or legal entities.

All data except personal data and electronic records that belong to the sphere of personality is not considered as confidential and protected data.

The need for collecting personal data and electronic records that belong to the sphere of personality will be explicitly announced, so the visitors will be adequately informed about it.

In case there is a certain space on the Website for entering personal data, the person who enters them by the act of entering voluntarily puts the same data at the disposal of PTS Logistic Solution.

Data on the system from which you are browsing or using the contents of the Website, such as IP addresses are collected automatically, with the aim of improving user experience, in order to enable easier access to the content of the Website.

PTS Logistic Solutions does not automatically exchange collected personal data with third parties and takes the appropriate measures of legal and other protection against unauthorized access before it.

Cookies

In order to improve the user experience, in order to facilitate easier access to the content of the Website, this Website leaves a quantitatively limited group of information on the system from which the content of the Website is subject to browsing, so called cookies, with the explicit consent of the person performing the browsing. By rejecting this feature, the visitor is limited in functional terms.

So called cookies can be permanent, which remain on the system from which the Website is viewed, temporary, placed at the time of browsing and using the content of the Website, as well as statistical cookies.

The placement of this group of information can be denied while browsing the Website and by using the performances of the system from which the Website browsed.

Other clauses

1. PTS Logistic Solution reserves the ability to modify this Privacy Statement, which will be made without prior notice, or without warning.

2. In the event that any part of this Privacy Statement is declared by the competent authority as invalid or unlawful, this part shall be automatically replaced by a provision or text that is valid and lawful, which corresponds most closely to the meaning of the replaced work, in accordance with the laws of the Republic Serbia.

3. PTS Logistic Solution reserves the right to submit the collected personal data to competent court or any other state authority, if it is a legal obligation or in case of any type of dispute. If this is not required under those circumstances, PTS Logistic Solution will refuse, without the permission of person who can be identified through collected personal data and electronic records that belong to the sphere of personality, to make them available to any party, on any basis.

4. In the event of a dispute arising from the interpretation or use of this Privacy Statement, the First Basic Court in Belgrade shall be the competent, law of the Republic of Serbia is relevant, and the Serbian language version of this Privacy Statement shall take precedence over its English version.
